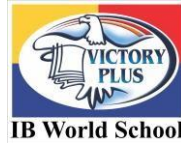

There are eight (8) criterion:

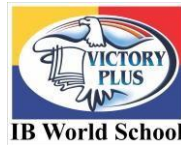
- Criteria 1: Policy Coherence

- Criteria 3 : Topic Research
- Criteria 4 : Solutions
- Criteria 5 : Diplomatic Charisma
- Criteria 6 : Engagement
- Criteria 7 : Draft Resolution
- Criteria 8 : Sponsor and Partner

The maximum score for each criterion is four (4).

Thirty two (32) is the highest score which any candidate can receive.



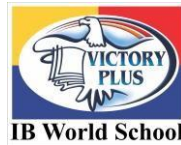

Criteria 1: Policy Coherence	Points Available
The delegate always represents the viewpoints and policies of his / her nation. All his / her speeches and negotiations demonstrate the best interest of their country.	4
The delegate always represents the viewpoints and policies of his/her nation. Most of his/her speeches and negotiations demonstrate the best interest of their country.	3
The delegate usually represents the viewpoints and policies of his / her nation. Most of his/her speeches and negotiations demonstrate the best interest of their country.	2
The delegate rarely represents the viewpoints and policies of his/her nation. His /her speeches and negotiations did not demonstrate the best interest of their country.	1



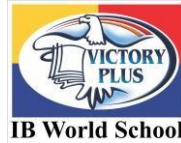

The delegate displays above average knowledge of UN structure and functions. He / she demonstrates this skill throughout the debate.	3
The delegate has some knowledge of UN structure and functions. He / she demonstrates this skill throughout the debate.	2
The delegate has little or inaccurate knowledge of UN structure and functions. He / she demonstrates this skill throughout the debate.	1



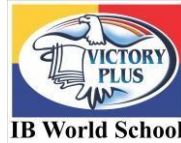

The delegate has little or an inaccurate knowledge of the topics.	1



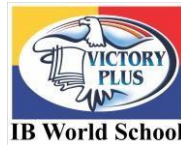

Criteria 4 : Solutions	Points Available
The delegate always has solutions for the important matters. His/her solution is used as the main solution in the resolution.	4
The delegate usually has solutions for the important matters. His/her solution is written in the resolution.	3
The delegate has some solutions for some problems.	2
The delegate doesn't have any solutions for the problems.	1



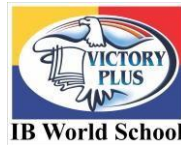

Criteria 5 : Diplomatic Charisma	Points Available
The delegate always acts in a diplomatic manner during speeches, negotiations and committee proceedings. He / she uses sophisticated language.	4
The delegate always acts in a diplomatic manner during speeches, negotiations and committee proceedings. He / she uses highly appropriate language.	3
The delegate usually acts in a diplomatic manner during speeches, negotiations and committee proceedings. He / she uses appropriate language.	2
The delegate does not act in a diplomatic manner during speeches, negotiations and committee proceedings. He / she shows competency in the use of language.	1



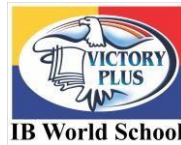

Criteria 6 : Engagement	Points Available

The delegate is actively involved in both formal and informal debates. He/she shows good enthusiasm and leadership.	2
The delegate is not actively involved in neither formal nor informal debates. He/she shows some enthusiasm and leadership.	1



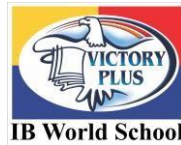

Criteria 7 : Draft Resolution	Points Available
The delegate has outstanding knowledge of writing a draft resolution. He / she acts as the main drafter.	4
The delegate has some knowledge of writing a draft resolution. He / she contributes to the drafting process.	3
The delegate has basic knowledge of writing a draft resolution. He / she contributes ideas to the draft resolution.	2
The delegate has little or inaccurate knowledge of writing draft resolution. He / she barely contributes to the draft resolution.	1

Criteria 8 : Sponsor and Presenter	Points Available
The delegate is both the sponsor and the presenter of the draft resolution. He / she manages to explain the draft clearly and able to answer key questions.	4
The delegate is both the sponsor and the presenter of the draft resolution. He / she manages to explain the draft clearly but unable to answer key questions.	3
The delegate is both the sponsor and the presenter of the draft resolution. He / she cannot explain the draft clearly.	2
The delegate is a sponsor of the draft resolution.	1
